# **EITS Web team and History:**

The State of Nevada Department of Administration, Division of Information Technology System (EITS) Enterprise Web team first started working on ADA compliance in 2001.

Governor Guinn's created an Executive order requiring ADA compliance as well as a consistent look and feel (branding) for all state websites. One feature that was lacking on the current FrontPage websites was robust site navigation, so an enterprise version of AJMENU was purchased. Bobby, a free ADA compliant checking tool, was also selected to assist in making our state websites compliant. The Manager of the EITS web team conducted three group training classes for 60+ website coordinators at agencies that used our services so they could begin to assume editing responsibilities for their websites. During those training sessions, users were provided a prototype website built especially for each individual agency complete with new AJMENU navigation that were Section 508 compliance. A training website was also created that hosted instructions, templates, style guides and other tools to assist agencies in redesigning their existing content to meet the branding and ADA requirements mandated by the Governor. After the last class, agencies were given 30 days to make homepages compliant and 90 days for the entire sites to be ADA compliant with new branding. *This goal was met, unfortunately without an ADA monitoring tool in place; the sites did not stay compliant very long*.

In 2015, articles about ADA compliance started to circulate and we realized we needed to once again put our efforts on making the State of Nevada CMS ADA compliant. When doing our research, we realized how big an initiative it really was. We discovered a free ADA compliance tool, Wave, however the Wave had some limitations:

- It would only remediate one page at a time
- The tool identified and flagged issues, however, understanding how to fix them was another huge effort that made us realize we needed to learn a lot more if we wanted to continue

EITS Enterprise web team needed to become proficient in ADA remediation.

- We found Lynda.com and took many ADA training classes to understand what was needed to remediate not only HTML content, but all of the documents that resided in the websites
- We found Brett Silver, manager of Talking Books in Las Vegas
  - o Brett was blind at birth
  - Brett offered to use JAWS to help us test the Smart forms and templates in our CMS environment

    - Other resources

- o Research of other 50 states
  - Collaborated with State of Michigan

EITS Enterprise web team then started to reconcile all of the information collected, and began to put a plan in place.

- List all components of ADA that needs to be addressed
  - State of Nevada CMS environment
  - CMS websites
    - Websites using our templates
    - Websites in our CMS environment that do not use our templates
  - CMS Templates
  - CMS Smart forms
- Researched ADA Compliance tools and found the Siteimprove tool to be the most comprehensive
  - Siteimprove
    - Recommended tool to Management but was not purchased because of funding
- Department of Justice, Office of Civil Rights cited the Department of Education (DOE) for not being ADA compliant
  - Met with DOE, and recommended Siteimprove to help them remediate their sites
    - DOE and EITS agreed to purchase the tool for DOE
  - EITS web team staff needed to take ADA classes to understand ADA remediation
    - EiTS web team also needed to get approval from OCR to train DOE Webmaster
  - o EITS web team staff worked with the Department of Education and the Attorney for the Department of Education
    - Wrote documentation results for OCR, and answered OCR questions whenever needed
  - EITS web team staff continues to work with OCR and Siteimprove to assist in making DOE ADA compliant



# **Details of Document Training**

## Accessible Word, Excel & PowerPoint Documents

Assistive Technologies traverse documents using semantic tags. It will present a list of page headings <h1>, <h2>, <h3>, etc. that the user uses to scan to the topic they are using . If headings are not used to section the page a screen reader user must read the entire document to locate the information they are looking for when they should be able to traverse to the section they want using the headings and only read the portion of the document they want. Just like a sighted user would scan the page and hone in on the section that contains the information they are looking for.

#### AVOID LONG PAGES OF TEXT WITH NO SECTION HEADINGS

- Methods of Conversion from Office Doc to PDF
- Going to print > PDF creates an inaccessible document as it does not migrates styles, tags, etc. to the converted document
- Going to Save As and choosing PDF also creates an inaccessible document
- You must see the Acrobat tab in the Office product in order to migrate semantic markup

### **Best Practices**

- Use templates for specific documents
- Use title, heading styles, body style, etc.
- Add alt text to images and links
- Use captions for images, tables and equations

- Always provide expansion text for acronyms spell it out the first time there is some debate on not
  spelling it once in each section because A sightless user may skip the section the expansion text is provided in.
- Use standard and easy to read fonts like sans-serif fonts like Arial and Verdana
- Use good color contrast
- Use plain language or plain English
  - Consider your target audience
  - Convey ideas with clarity
  - Don't sound formal; omit unnecessary details
  - Scale back info and use examples only what reader needs to know
  - Use active voice whenever possible emphasizes the doer of an action and is usually brifer and clearer than the passive voice
- Identify table header rows repeat header rows at top of each page
- Avoid text boxes in Word. They stand alone on the page like they are floating over other elements and appear at the far left margin and so the the screen reader will not identify the box and the sightless user will not gain the information in a text box.
- Avoid single-cell tables in Word
- Create a single image out of grouped object and add alt text
- Where an image is very complex, provide a separate descriptive document to explain the complex image. Make sure the document is accessible

## **Accessible Word Documents**

- Add styles, headings and designate body text, footers, etc. to make text accessible
- Always provide expansion text for acronyms spell it out the first time there is some debate on not spelling it once in each section because A sightless user may skip the section the expansion text is provided in. Avoid creating space using the spacebar set proper tab stops instead
- Avoid creating space between paragraphs by pressing the enter key multiple times set spacing between paragraphs
- Create proper page breaks rather than by pressing the enter key multiple times to go to the next page
- Make images accessible
- Make tables accessible
  - Merged and split cells are not accessible in Word if the document will be converted to pdf you can tag the merged or split cells in Adobe Acrobat
  - must have header rows
  - watch contrast issues
  - Tagging tables for accessibility in word
- Making hyperlinks accessible
- Making lists more accessible
- Using text-to-speech functionality
- Considering object order for screen readers
- Adding metadata

### **Accessible Excel Documents**

- Formatting cells for accessibility
  - Merged/split cells are not accessible (to fix on HOME toolbar click drop-down next to Merge & Center and choose Unmerge Cells) or fix in acrobat if the document will be converted
  - use san-serif fonts (Arial & Verdana)
- Naming sheets for navigation
- Creating accessible objects
- Creating accessible tables
  - no merged cells
  - must have header rows
  - watch contrast of rows
- Creating accessible hyperlinks
  - must have alt text just like tables
- Considering object order for screen readers

### **Accessible PowerPoint Documents**

- Design considerations for accessibility
  - Avoid backgrounds with textures, pictures or dark colors
  - For better visibility we should have plain simple backgrounds with good contrast (like black text on white background) solid color or no color at all.
- Always provide expansion text for acronyms spell it out the first time there is some debate on not spelling it once in each section because A sightless user may skip the section the expansion text is provided in.
- Making objects more accessible
- Adding alt text to media
- Considering object order for screen readers

### Accessible PDF Documents

- Easiest to do most of the work in source document. Much more time consuming and complicated to correct items in Adobe Acrobat. Remediation after the fact is difficult.
- Understanding the experience for users with visual impairments we scan the headlines to look for information of interest rather than reading the whole page
  - JAWS
- All PDF files are not created equal. Much depends on the semantic markup applied in the source document (examples tri-fold brochure)
  - tags navigation pane right click on the toolbar to the far left and choose the tags pane if it is not visible
  - Text in images are not tagged and degrade when enlarged or magnified
  - Text that can be selected can not only be tagged but it doesn't degrade when magnified and lowers file size
- Understanding reading order
- Keep contrast in mind
- Always provide expansion text for acronyms spell it out the first time there is some debate on not spelling it once in each section because A sightless user may skip the section the expansion text is provided in. You can do this with a tag in a PDFs document. Apply it in every section an abbreviation occurs.
- Understanding design considerations

- Simple designs render more easily to accessibility
- Agency spec
- Checking and fine-tuning the PDF after conversion from Word
- Understanding PDF remediation in Acrobat
  - Adding tags to an Acrobat document
  - Fixing elements using the content panel
  - Artifacting an element means you are removing the semantic tags from an element so it will be ignored by assistive devices these are images or objects that don't add meaning to the content make this a background element in the touch up reading order tab. This can also be done in the tags panel.
  - Tagging tables order panel select table (Table Editor)
  - Tag it as a table
  - Identify Header rows
  - Apply scope
  - Adjusting document properties
  - Metadata Description tab add Title, Author, subject, keywords
  - Initial View tab under Windows options SHOW select document title instead of file name
  - Advanced tab define language as English
  - Adding bookmarks is a way of adding additional navigation for both sighted and sightless users
  - Adding alternative text (images that are tagged must contain)
  - Add it via the orders panel go options & show reading order panel, click on figure and right-click and choose edit alternate text
  - Tags panel click on figure right-click and choose properties and enter alt text
  - Converting a PDF back to a native format this may be an option for small documents or large ones if you have no other choice as it is easier to remediate it in the source application than in the Acrobat.
  - PDF2ID will export something from InDesign so you can add accessibility features
  - Checking and fine-tuning the remediated PDF
  - Always run it through the accessibility checker at the end to be sure of compliance
  - Using the Make Accessible Wizard
  - Click tools pane > open Action Wizard category > Make Accessible
  - Table of Contents should link. How you do this will vary depending on your version of Adobe Acrobat

It is much easier and quicker to add accessibility features to a word, Excel or PowerPoint document than it is to remediate the accessibility issues after conversion to PDF.

## A Brief Overview Website Accessibility (Video 1)

**Justification for this video:** As the users develop more accessible sites and use the resources/tools we direct them to, it is important that they have a base level understanding of some nomenclature related to ADA, DOJ, And WC3. This video will help the user understand the groups that govern accessibility standards.

- ADA Section 508
- Department of Justice
- W3C WCAG 2.0
- ADA is not just about websites, talk about the Physical ADA in (video 3)

## Three Reasons for Accessible Websites (Video 2)

**Justification for this video:** Without delving too much into the legal aspects of accessibility, I think it's important to make sure that the user viewing/reading this content understand that accessibility is required by the feds and follows best practices for individuals with disabilities as well as the best way to structure a site for search engine optimization, site maps and overall structure/organization.

- The Federal government is in the process of reviewing state agencies that take federal money for compliance with ADA Section 508
- It's the best way to make sure that all citizens have the ability access information and services.
- It's the best way to structure a website for sited users and search engine optimization as well.

## **Barriers to Website Accessibility (Video 3)**

**Justification for this video**: One of the things about accessibility is that it seems like there is a high premium placed on sighted or unsighted users, but one thing our user base needs to sufficiently understand the accessibility issues faced by other disabilities.

- Physically impaired who do not have use of their hands may need to use speech recognition to navigate the website.
- Blind individuals may need to use screen readers and other assistive technology to convert visual information into speech.
- Visually impaired individuals may be able to see text but require the ability to zoom in without losing resolution, or may need higher contrast between text and backgrounds on the website.

- Hearing impaired individuals may need subtitles or transcripts for multimedia like audio and video that is included as part of the website.
- Cognitively impaired individuals may not be able to read and/or retain quickly enough for content that times out.

**ADA** Americans with Disabilities Act, make sure you talk about this. It is the physical <u>ADA compliance</u> like making sure there are ramps for wheelchairs at the DMV, etc. add the link to the page it links to

## Accessibility Standards for State Websites (Video 4)

**Justification for this video** – As our users start to use the tools and the documentation, they will stumble across the standards levels Single A, Double A and Triple A. I think it's important that they are aware that the they need to bring their sites in conformity with Single A/Double A compliance and understand a bit about what that means. *Make sure you explain the detail and the differences.* **DOUBLE A is what we are required to be.**

- Double A
- Triple A (not required, but something to be aware of)
